The scholarship applicant must be planning to attend or currently attending an educational institution with plans to work in the construction industry; including High School and College/University students. Proof of enrollment will be required upon redeeming the scholarship funding.

Applications must be submitted to the Southern Interior Construction Association's head office in Kelowna, BC. The scholarships are valid for two years from the date of issue.

## SCHOLARSHIP PROGRAM

Applications must be submitted to the Southern Interior Construction Association's head office in Kelowna, BC; the scholarship is valid for two years from the date of issue.

# SELECTION PROCESS

Applications will be reviewed by the SICA Education Committee. All applications will be evaluated based on:

- Academic Achievement 10 points
- Extracurricular Activity 35 points
- Essay Answers 55 points
- Total: 100 points

### **CRITERIA**

All applicants must be a permanent resident within the Southern Interior region of British Columbia. To enter, all applicants will be required to provide:

- an essay or video (maximum 3.5 minutes) demonstrating interest and involvement in the Construction Industry.
- a letter of reference from a current employer SICA member or instructor.

The content of your essay and/or video should aim to address the following questions:

- Why did you choose to pursue a career in construction?
- How will you use your studies to better our region?
- What are the barriers facing students wishing to pursue a career in construction?
- Where do you see the construction industry in 10 years?

- 3. Applicants must not have been a previous recipient of a SICA Scholarship.
- 4. Applications will be reviewed under the discretion of the SICA Education Committee. The decision made by this Committee is final.
- 5. The SICA Education Committee will be responsible for evaluating the entries based on the following considerations/ criteria. Essay answers will be scored based on clarity of thought and communication, persuasiveness and potential positive impact.
  - Academic Achievement: 10% of total score
  - Extracurricular Activity: 35% of total score
  - Essay Answers: 55% of total score
- 6. Recipients will have two years from when the Scholarship is given to use for furthering education in the construction industry. It will be the recipient's responsibility to keep track of this time limit, as it will be the responsibility to notify the Southern Interior Construction Association (SICA) when you intend to use this scholarship.
- 7. SICA reserves the right, in its sole discretion, to modify, amend (including extending the Scholarship application deadline) or cancel this Scholarship program at any time without individual notice.
- 8. Scholarships will be awarded by August 15th of each year. Scholarship winners will be requested to attend a SICA function to be officially presented with their scholarship by the Education Committee and Association President.
